Your step by step guide?

We want you to start using this toolkit now. Firstly, use the flowchart to guide you through the PPE selection and Risk Assessment process. Then depending on the task, introduce the relevant Safety Conversation. This step by step guide will help you.

- Again ensure you allow time to discuss any issues raised.
- Complete the relevant Safety Conversation Training Record.
- Next, share the relevant Hand Protection posters with your colleagues.
- Discuss where best to display and use these materials – and answer any questions.
- Reinforce that all Units within Compass will be following the same process.
- Remind everyone that we want all accidents/near misses reported.
- Thank everyone for their time.

What's new?

We want to focus on safety behaviour and encourage colleagues to own their safety and that of others.

- Safety Conversations to deliver a clear and simple development activity that can be validated and recorded
- Risk Assessments that require you to add the detail of the hand protection PPE you provide

Sectors have identified certain tasks as requiring prescribed PPE and we have included clear guidance to assist and direct you in identifying and assessing tasks/risks, then selecting PPE.

You must read the contents of your pack, and then action appropriately the guidance and support materials available to you in the pack and the HSE website.

Using Your toolkit

Safety Conversations (PDF and Powerpoint)

There are 5 Safety Conversations that cover the 5 main areas where we have identified risks to health and safety arising from work activities. Risks can be reduced by informing colleagues about the hazards.

All colleagues must complete the Introduction to Hand and Arm Protection Safety Conversation. You can then decide which additional Safety Conversations your team need to complete. The best way for you to make the choice is to refer to your Hand PPE Requirements Guide. If you are still unsure contact your HSE Manager who will support you.

The Safety Conversations are available to download as pdf documents or PowerPoint presentations for group sessions We have added blank slides that allow you to add contract/ site-specific information or actions.



Posters

There are 9 posters in the toolkit that cover all the key areas/ tasks where hand protection is required. Consider displaying the posters in rotation at your contract to keep the messages relevant and focused.



Hand PPE Requirements Guide

The guide will assist you in selecting the appropriate PPE for the task that you have identified. The task list is comprehensive and covers the whole business and advises of the PPE required. If you identify any additional tasks that are not listed, you can create your own Risk Assessment. Contact your HSE manager for support if required.



Risk Assessment Completion Guidance

This is a simple step by step process for you to follow and to complete your site specific Risk Assessments. A series of generic Risk Assessments are available that will deliver the majority of your requirements. These have been designed by your HSE team with operational inputs. BUT remember that you need to make the Risk Assessments specific to your contract/site.

Example Risk Assessment

There are generic Risk Assessments available for you to download. Guide and the Risk Assessment Completion Guidance. The main change is that you must now list the PPE provided by product type, and where no PPE is provided based upon the (Hand PPE Requirements Guidance) you must amend the Risk Assessment accordingly.



Training Record Cards

You must record all the Safety Conversations that you deliver to your teams on the training record cards.



Glove Selection Chart

The chart gives you the recommended PPE for use in your services with the key specifications and guidance on how to order via our existing system. All the detailed specification sheets for each product and applicable sizing charts are available from the HSE Website.



Safety with Blades and Sharp Edges




