Evacuation chairs

Safe System of Work

- 1. You must be trained in how to operate evacuation chairs, including physical training using the chair with dummy weights.
- 2. Anyone with a physical injury, and new or expectant mothers, must not operate an evacuation chair.
- 3. Do not exceed the maximum carrying capacity of the evacuation chair.
- +. Any person over 80kg should be moved by two operators.
- 5. Always follow guidance from medical staff and fire wardens.
- 6. If access is restricted, additional help may be required.
- 7. Check the evacuation chair visually and prepare it for use.
- 8. Ensure the patient is aware of what is happening.
- 9. Always use chair constraints.
- 10. Check the patient is secure before moving the chair to the top of the steps.
- 11. If available, a second person can help guide the chair to the top of the steps.
- 12. Check that both front wheels are square with the top of the step.
- 13. Tilt the chair and push the rear wheels into the folded position, so that the track is free to sit on the stairs.
- 14. Leaning the patient slightly back, push the evacuation chair carefully down the first step.
- 15. Make sure you hold the chair securely at all times NEVER LET GO.

Safe System of Work continued

- 16. Continue to guide the chair down the steps, keeping it straight and square with the steps.
- 17. On landings, lift the chair slightly to put weight onto the front wheels, and guide the chair to the top of the next set of stairs.
- 18. Once you have arrived at the bottom of the stairs, tilt the chair forward slightly, pull the rear wheels out and continue on all four wheels.
- 19. The chair must be regularly checked to confirm it is in good working order:
 - Check for damaged or dented parts and missing fastenings.
 - Make sure wheels rotate freely and that there is no excess movement or other damage.
 - Check the chair unfolds and locks securely into the sitting position.
 - Make sure that upholstery is securely attached to the frame and that there is no damage.
- 20. Report any damage or concerns to your manager.
- 21. Faulty evacuation chairs must be removed and replaced.
- 22. Ensure that the chair is checked and returned to its usual place of storage after each use.
