Stage 1	Follow machine manufacturer's instructions.
Stage 2	Use the number of tablets indicated on the oven display panel.
Stage 3	Remove protective foil from the detergent tab.
Stage 4	Place detergent tabs into the recess in the air baffle.

First Aid Information:

Product Concentrated

Eye contact	Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.
Skin contact	Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning.
If inhaled	Move to fresh air in case of accidental inhalation of vapours.
If swallowed	Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Do not induce vomiting. Consult a doctor.

Suitable extinguishing media for the surrounding fire should be used.

Store in cool, well ventilated area. Keep container tightly closed. Storage class: 8B (Non-combustible corrosive substances). Must only be kept in original packaging. Do not mix with other chemicals.

Accidental Release Measures

- If an accidental release occurs ensure people and colleagues are moved away.
- Ensure the spill is dealt with by trained colleagues (i.e. know how to deal with spills and how to use spill kits) and wear appropriate PPE.
